- A contract has been signed on the condemnation for the Harper property, trailers 1 & 2. Once the weather permits is should take about a day to complete.
- Property tax notices were mailed out today 11/13/18.
- 1st Annual Fishing Rodeo has approximately 200 participants.
- The off the leash dog park has been constructed. The fencing and gates are finished, we still have some signage and the water to complete before it is opened.
- The vehicle leasing agreement with Enterprise Fleet is in full swing. We gotten all but 1 or 2 of the vehicles. Once the insurance in place we will get them on the road.
- The work on the Safe House should start sometime within the next couple of weeks and take about 10 months to a year to complete, weather permitting.
