

There being no additional comments and no new business to discuss, Mr. Richard Wales made a motion, seconded by Mr. Gary Griffin to adjourn.



During additional comments, Mr. Jamie Etheridge informed the Council that Fire District 4 would be performing flushing of the fire hydrants.


There being no additional comments or no new business to discuss a motion was made by Mr. Richard Wales and seconded by Mr. Eric Cook to adjourn.
