



ELIGIBILITY REQUIREMENTS

Go to scpdc.org to apply online for a 0% interest loan.

1 BUSINESS LOCATED IN ONE OF THE 51 IMPACTED PARISHES

Your business, if located in one of the 51 impacted parishes, must have been open prior to April 8th to be eligible under the March flood or open before August 31st to be eligible under the August flood.

3 MUST HAVE 1 FULL TIME EMPLOYEE

A minimum of 1 full time employee is required, and you may not have more than 50 full time employees. (Having 35 or more hours weekly is considered full time.)

2 BUSINESS CURRENTLY OPERATING

You must be **currently operating** your business or be able to demonstrate **ability to reopen**.

4 GROSS REVENUE OF \$25,000

Your business must have a minimum annual gross revenue of \$25,000.

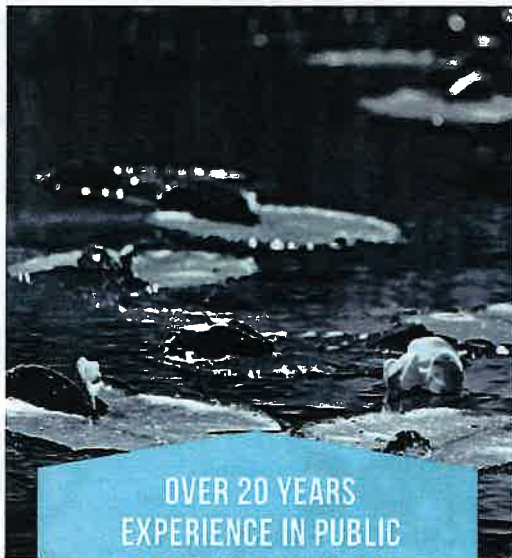

TYPE OF ASSISTANCE

- Interest rate is 0%
- No principal payments due for the first 6 months
- 5 year loan term
- Loan amounts from \$20,000 - \$50,000
- 20% of the total loan MAY be eligible for forgiveness



HOW TO QUALIFY

\$10,000 "out of pocket" physical damages due to the March and/or August 2016 flood events/storms.

OR

20% Loss of Revenue due to the March and/or August 2016 flood events/storms
